



"Dizzy's on the money"

Terms and Conditions of Entry

- 1) The promotion is called "**Dizzy's on the money**" (**Promotion**).
- 2) By entering this Promotion, Participants accept and agree to abide by these Terms and Conditions of entry (**Terms and Conditions**). Information on how to enter and prize details form part of these Terms and Conditions.
- 3) The Promoter is Australian Central Credit Union Ltd trading as People's Choice Credit Union (**People's Choice**), ABN 11 087 651 125, Australian Financial Services Licence 244310 and Australian Credit Licence 244310 of 50 Flinders Street, Adelaide SA 5000. Ph: 13 11 82 (**Promoter**). The Promotion is conducted in South Australia.
- 4) The Promotion commences at each of the seven Adelaide Strikers home games (collectively, the **Home Games**) commencing on Monday 23 December 2019 and closing on Sunday 26 January 2020. Refer to the table below for dates.
- 5) Prizes consist of:
 - (A) one (1) \$250 cheque from People's Choice (**Major Prize**) following each of the seven Strikers Home Games. Seven (7) cheques in total across all seven Adelaide Strikers 2020 season Home Games, valued at \$1,750 total. Each winner then has the opportunity to double their winnings to \$500 by opening a People's Choice Transaction Account (subject to eligibility), valued at a further \$1,750. Total Major Prize pool valued at up to \$3,500.
 - (B) two (2) \$50 Anystore Eftpos Gift Cards (**Minor Prizes**) at each of the seven Strikers Home Games. Fourteen (14) Minor Prizes in total across all seven Adelaide Strikers 2020 season Home Games, valued at \$700.(each a **Prize** and, together, the **Prizes**). Maximum total prize pool is valued at \$4,200.
- 6) To participate in the Promotion you must:
 - (A) be a resident in Australia;
 - (B) be aged 13 years or over
 - (C) be in attendance:
 - during the innings break at the first Adelaide Strikers' Home Game on 23 December 2019
 - pre-game at the remaining six Adelaide Strikers' Home Games, in the seating bowl within the stadium at Adelaide Oval (refer to the table below for dates and times)
 - (D) raise a hand to indicate consent to participate in the Promotion when prompted by the MC
- 7) The prize winners will be selected from the participating audience in attendance either during the innings break or pre-game at each of the seven Adelaide Strikers Home Games.
- 8) The Major Prize winners will receive instructions (**Instructions Letter**), on the Terms as set out at 8(A) to 8(E) below, on how to claim the Major Prize amount at the time of being declared a Major Prize winner.

- (A) To redeem the \$250 cheque, the Major Prize winner must contact People’s Choice by following the details set out in the Instructions Letter provided to them at the time of being declared a Major Prize winner. The \$250 cheque can be deposited into any account of the Major Prize winner’s choice. The \$250 cheque must be claimed by the date listed in the Instruction Letter (see table below).
- (B) For the opportunity to double their winnings to \$500, the Major Prize winner is required to open, or already have, a transaction account with People’s Choice– such as an Activate, Zip or Everyday*^ (subject to eligibility criteria). - (C) Once the new transaction account has been opened, or if the Major Prize winner already has an eligible transaction account with People’s Choice, the Major Prize winner needs to contact the People’s Choice person listed in the Instructions Letter provided and reference their:
- People’s Choice Credit Union member number
 - transaction account number
 - Name and Surname
 - Reference number provided in the Instructions Letter
- (D) Eligible Major Prize winners with an existing People’s Choice transaction account will receive the \$250 ‘double your winnings’ payment directly into their People’s Choice transaction account.
